# 1 Respective responsibilities of the body and the auditor

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections and 2 of the Annual Governance and Accountability Return is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

As part of its Annual Governance and Accountability Return submission the Council is required to provide for audit explanations for significant variances between the 2017/18 and 2018/19 figures in Section 2. Such explanations support the Council's own understanding of its financial performance. For 2018/19 the Council provided insufficient explanation of its variances because not all variances above the tolerance level were explained in the documentation provided. In future, the Council should provide an explanation for all significant variances in its submission.
